> and the second of the second o ' The Trial of Kissane. This important trial was continued yesterday in the Court of General Sessions. Our extended report is crowded out, owing to the pressure of for-eign and other intelligence. The evidence taken yesterday was important, showing as it did, the expert manner in which the forgery was conducted, from the initiatory proceedings to its magnificent consummation. The principal witness examined was ROBERT H. FALLS, a member of the firm of NATHAN, LANE & Co., No. 69 Wall-street-the well-known printers of Bankers' check books. He testified to KISSANE's calling on him in August last, and, under the excuse of wanting a check book printed, desiring to look at specimens of checks. He approved of the patterns of the checks used by JOHN THOMPSON, of the Bank Note Detector, and Messis. VERY & GWYNNE, and requested to be allowed to take away specimens to show to his partner. On those specimen checks, thus obtained, the forgery was executed. Another important witness was Mr. WATERHOUSE, a member of the firm of VAN BRUNT & WATERHOUSE, in Chambers-street, who introduced KISSANE to the Chemical Bank and made deposits for him. The case is continued to day ; a full report will be published as usual to-morrow.

The Massachusetts Case.

Yesterday morning, before Judge HALL, in the United States District Court, was resumed the investigation into the Massachusetts case.

Mr HITCHCOCK, of the firm of HITCHCOCK & BURROUGHS, called, from whom it is alleged were purchased the wagons, pistol-holsters, and other fillibustering articles, refused to produce his account books, on answer that it might commit him.

A. W. HUTCHINSON, clerk of the aforesaid firm, declined to state what Mr. OAKSMITH had purchased; he acknowledged having sold him muskets and cannon for the White Squall.

JAMES P. HUSTEED testified to furnishing twentyfive thousand gallons of water for the Massachusetts. Mr. FARDEN sworn to a large additional supply by the Croton Aqueduct Company.

Captain EDWIN R. HANCKS stated that Captain GOODRICH informed him the Massachusetts, was going to Texas to engage in the cattle trade. JOHN R. MORROUGH, third mate, and Mr.

BREKENWRIGHT swore that the Massachusetts' destination was New-Oileans. The reason the steamer hauled out at night, the third mate stated, was because they were afraid of going ashore.

MICHAEL RIORDON, first engineer, testified to other engineers leaving the steamer, but did not state the reason.

The examination will be continued to-day.

Beard of Education.

The Board of Education last evening, after a long debate, resolved to again make applica-tion to the Common Council for an appropriation of \$198,000 to meet the deficiencies in the School monies for 1854.

Ship Building.

Messrs. PEASE & MURPHY, of the Fulton Iron Works, foot of Cherry-street, have laid the keel for one iron boat for the Panama Railroad Company, Panama, N. G. They expect to have it completed in about four weeks.

A young women complained at the Mayor's office of a party in William-street, from whom she received sixteen vests, for the making of which she was to receive thirty-one cents each. The tailor refuses to pay her for the work, demanding that she shall take goods instead of money, in part payment.

THE POOLE MURDER. FLIGHT OF BAKER FROM THE BRIG. THE SEARCH FOR HIM IN JERSEY. ACTION OF THE COUNCILMEN. \$5,000 REWARD OFFERED. The Alleged Perjury. DESCRIPTION OF THE CULPRIT. [For Inquest Proceedings See Third Page.].

From information received yesterday, it appears that numerous efforts have been made to baffle the authorities, who were on the trace of BAKER, the murderer of Poole. That he took passage on board of the brig Isabelta Jewett, while lying in the stream off the Battery, is beyond all question. Yesterday morning Judge STUART returned frem New-Jersey, where he had been during the night searching for information respecting the flight of LEWIS BAKER from the brig in which he sailed last Saturday morning. It appears from all the facts gleaned by Judge STUART, that BAKER became frightened, and thinking the authorities would overtake him before reaching the Canary Islands in a sail craft, he accordingly succeeded in the Captain of the Jewett to set him getting ashore in the vicinity of South Amboy, N. J. There were at least twenty Jerseymen called on Judge STUART yesterday, who describe BAKER to the very letter, and proclaim that they saw the culprit, on their shores, since the brig left. Each and overy man agree in regard to the description of the felon, and the latest news of his movements places him at a farmhouse near the village of Englishtown, wending his way in the direction of Camden, opposite Philadelphia.

THE POLICE DISPATCHED TO NEW-JERSEY.

Yesterday atterncon Captain GEO. W. WALLING and Captain Speight left the City for the south part of the State of New-Jersey, with a strong force of Police Officers, to search for the fugitive, who is no doubt lying in the woods this side of Camden. It is the intention of this posse to procure assistance if necessary, and thoroughly search every house, hut or wood in the Counsies of Monmouth, Burlington and Camden, for the places of concealment of the offender. The result of this last movement will no doubt be known to-day. DESCRIPTION OF THE FUGITIVE.

Below we give a full description of the fugitive from justice, as noted by Judge STUART :

justice, as noted by Judge STUART: LEWIS BAKER is a large, heavy man—about five feet nine inches high—broad chest—weighs nearly 190 pounds—supposed to be thirty-five years of age—light complexion—brown hair, inclined to curl—full round face—blue (yes—large head—thick lips—head and neck projects slightly forward—several marks with India ink upon both arms—a star with India ink upon one hand, between the thumb and forefinger—his face (at present) slightly scratched—one eye "blood-shot"—a wound nearly well upon his forchead, passing up into the harf—also, a wound upon the lower part of the abdo-men, four or fine inches above the groin, still so sorious as to disable him from running or walking last—had on a cap, and brown overcoat of bear skin, or other long nap cloth. (It is hoped that newspapers throughout the country will publish this description, that the offender may not finally escape.] ACTION OF THE BOARD OF COUNCILMEN.

ACTION OF THE BOARD OF COUNCILMEN.

The Board of Councilmen met last evening in Regular Session, and we are pleased to notice that prompt action was taken by President CONOVER in regard to offering a more suitable reward for the capture of the fugitive.

The following will be found a report of the proceedings. The resolution adopted authorizes the Mayor to increase the reward to \$5,000.

President CONOVER offered the following preamble

President CONOVER offered the following preamble and resolution: Whereas, WILLIAM POOLE was bratally murdered at Shenwix Hall, No. 579 Broadway, on the 25th Feb-ruary lat, and LEWIS BAKER, the principal perpetrator of the murder, has been permitted to escape arrest; and whereas, the police authorities of this City, in permit-ting the escape of said murderer, are partly looked upon with suspicion by our citizens; Therefore Resolved, That His Honor the Mayor⁵be authorized and directed to offer a reward of \$5,000 for the arrest and conviction of LEWIS BAKER for said mur-der, and that said reward be paid out of the City Trea-

To this several amendments were offered,—one to strike out the preamble, next to request the President of the United States to dispatch a Government steamer to the Canary Islands in pursuit of BAKER, aext to appoint a Special Committee of five from this Baard to join the steamer, and lastly, to reduce the amount of the re-ward. All the amendments were rejected and the origi-nal resolutions adopted—Ayes 36, Nays 14—three mem-hers being excused from voting.

THE PERJURY CASE.

Yesterday afternoon JAS. IRV ING voluntarily appeared before Judge STUART, at the New City Hall, and gave bail in the sum of \$3,000 to answer a charge of Perjury, which is alleged to have been committed by him at the Inquest before Coroner HILTON.

INTERVIEW BETWEEN THE MAYOR AND THE COLLECTOR. The Mayor had a conference with the Collector yesterday on the subject of sending the Revenue Cutter in pursuit of the vessel which it is supposed sailed with BAKER on board. Mr. REDFIELD immediately telegraphed to the Secretary of the Treasury for permission to do so, who replied, giving his assent. But it was discovered that the Cutter had sailed upon a cruise the day before. As soon as she returns she will be sent after the fugitive BAKER.
