[My Analysis: Company K appears to be reasonably well-equipped. The greatest shortfalls, overall, appear to have been for bayonet scabbards. Bayonets also seem to have in short supply as well. Significant shortages in such items as knapsacks, canteens, and canteen straps appear to have been addressed during the last week of August 1863, shortly before the Battle of Chickamauga. On the whole, this seems to provide support for the theory that while the Army of Tennessee did encounter periodic shortfalls for individual types of accourrements or personal equipment, it was well-armed. The numbers supplied for ammunition rounds on-hand indicate each man maintained at least 40 rounds in his box at all times undoubtedly in compliance with a directive issued by Braxton Bragg seen elsewhere by me.]
